Benefits

Sphera's EC4P has significantly reduced the time and cost for Symantec to achieve and maintain compliance by:

Background

Product sustainability goals

Symantec is committed to providing customers with technology that is designed, manufactured and used in a more sustainable manner. Symantec analyses products, parts, materials, and suppliers across the product development lifecycle to improve environmental performance. Examples include material management to use less materials and remove harmful substances, increasing recyclability and lowering the need to extract new raw materials. Symantec also incorporates recyclable materials in appliances and uses recycled content, such as paper laminates instead of plastics.

Recycling platform

Symantec has developed an innovative recycling platform which makes the recycling of Symantec and former Blue Coat Systems hardware easy and efficient, by providing the paperwork for return shipments to central collection points.

The platform supports Symantec's wider environmental program by prioritizing opportunities to reuse spare parts and relocate old inventory to avoid the purchase of new equipment. Refurbishment and reuse is especially important for e-waste which often contains metals such as lead, mercury, cadmium, gold, and silver.

Equipment that has reached the end of its useful life is sent to carefully selected waste management companies around the world for responsible recycling, using Sphera's EC4P managed compliance system. These waste management companies offer services such as hardware retrieval, asset tag and identifier removal, sorting, and environmentally responsible data wiping, cleaning, and destruction procedures.

Batteries can contain hazardous substances and require a special recycling process. Symantec has designed its products to enable easy removal of all batteries.

Environmental Compliance 4 Products



EC4P web platform

Sphera's EC4P (Environmental Compliance 4 Products; www.EC4P.com) is a centralised compliance platform which manages product registration, sales reporting and recycling fee payments for waste electrical and electronic equipment (WEEE), batteries and packaging compliance across all European countries and other countries around the world. EC4P manages and keeps up-to-date with all WEEE, batteries and packaging reporting requirements on one dashboard and one central location which:

- Gathers and displays WEEE, batteries and packaging reporting deadlines for Symantec product sales in each country
- Chases Symantec personnel who have been made responsible for reporting in each country as the deadlines approach
- Checks the sales data that the Symantec personnel enter into the EC4P system is in the correct format
- EC4P uses the Symantec sales data to calculate and pay the recycling fees on behalf of Symantec in each country
- EC4P issues annual Compliance Certificates for the WEEE, batteries and packaging regulations that Symantec complies with through EC4P

Symantec values the convenience of using one portal to submit all data needed for compliance to WEEE, batteries and packaging regulations around the world. Instead of completing different forms for each waste type in each country, EC4P uses one standard format to gather Symantec's product sales data and then EC4P translates the data into the different reporting formats required by each country.

Keeping up-to-date

Symantec takes pride in meeting all applicable legal and regulatory requirements for recycling of WEEE, batteries and packaging around the world. EC4P experts help Symantec stay up-to-date with changing regulations and help implement cost-effective and reliable compliance arrangements in each country.

Regulatory deadlines do not need to be monitored internally. EC4P sends email reminders for approaching deadlines and escalates email chains to senior management if required.

When Symantec personnel login to EC4P they see their regulatory deadlines displayed in a traffic light style, with recently submitted declarations shown in green, upcoming deadlines in amber, and overdue deadlines in red. Symantec personnel can also choose to display regulatory deadlines in a calendar format, showing how deadlines are distributed on a monthly, quarterly or yearly basis.

Symantec's innovative recycling platform enables Symantec to play an active role in promoting and supporting recycling initiatives around the world including the annual European Battery Recycling Day, organized by Eucobat. This event works to raise the awareness of consumers and businesses on the importance of collecting spent batteries for recycling. Several Symantec sites across the globe – including Cape Town, Dublin, Dubai, Paris, and Warsaw – took part last year.

In 2003 the EC4P team wrote the UK Government RoHS and WEEE Guidelines. In 2007 we were the first organisation to receive license to operate a WEEE compliance scheme in the UK. In 2008, EC4P represented the Medical Device Industry at negotiations with the European Commission on RoHS and WEEE compliance. EC4P won the Elektra European Electronics Industry Environmental Award in 2014 and won Environmental Leader Top Product of the Year Awards in 2015 and 2016.
